As per G.O.Ms.No.43 cited above, you are requested to take note of the following
The private Unaided Engineering including Pharmacy and Architecture colleges are permitted to collect

- Rs.1850/- per annum per student during the II year Pharm.D (P.B) course towards the common services rendered by the University to all the Colleges and such amount collected by the college shall be remitted to the concerned university.
- Rs.1500/- per annum per student during the III year Pharm.D (P.B) course towards the common services rendered by the University to all the Colleges and such amount collected by the college shall be remitted to the concerned university.

In view of this, the colleges are required to remit an amount of Rs.1850/- towards the Common services rendered by the University per candidate of the present second year and Rs.1500/- towards the Common services rendered by the University per candidate of the present third year Pharm.D (P.B). The requisite fee is to be paid in the form of a consolidated demand draft drawn on any nationalized bank in favor of "Registrar, JNTU Anantapur" payable at Anantapur. The demand draft is to be dated on or before 11.09.2017. The consolidated list of the second and third years Pharm.D (P.B) students admitted (enclose attested photocopy of the clearance certificate issued at the time of entry) along with the demand drafts should be sent by speed-post/registered post so as to reach the office of the Controller of Examinations by 14.09.2017 without fail. Hall tickets for the University examinations will be issued only to those students whose UCS fee has been received. You are requested to take separate demand drafts for each year. Please super scribe the cover as UCS Fee 2017-18/ Pharm.D (P.B)/II & III Years/<College Code>.
