As per G.O.Ms.No.43 cited above, you are requested to take note of the following

The private Unaided Engineering including Pharmacy and Architecture colleges are permitted to collect

- Rs.1850/- per annum per student during the II & III year Pharm.D course towards the common services rendered by the University to all the Colleges and such amount collected by the college shall be remitted to the concerned university.
- Rs.1500/- per annum per student during the IV,V and VI year Pharm.D course towards the common services rendered by the University to all the Colleges and such amount collected by the college shall be remitted to the concerned university.

In view of the above, the colleges are required to remit an amount of Rs.1850/- towards the Common services rendered by the University per candidate of the present Second & Third year and Rs.1500/- towards the Common services rendered by the University per candidate of the present fourth, fifth & Sixth years Pharm.D.

The prescribed fee collected from the students has to be paid through Online transfer into Power Jyothi Account SBI, JNTUEC branch, (Account No.32950804752, IFSC Code: SBIN0002723) OR Power Jyothi Account AB, JNTUEC branch, (Account No.225410100000131, IFSC Code: ANDB0002254). The receipts/challans should be submitted for account verification purpose. Transaction date should not be later than 27.07.2018 (Friday).

The consolidated list of the Second, third, fourth, fifth and Sixth years Pharm.D students admitted (enclose attested photocopy of the clearance certificate issued at the time of entry) along with the separate receipts/challans should be sent by speed-post/registered post so as to reach the office of the Controller of Examinations by 31.07.2018 without fail.
