MEMORANDUM OF UNDERSTANDING

BETWEEN

NATIONAL POWER TRAINING INSTITUTE (NPTI)
CORPORATE OFFICE, FARIDABAD

AND

JAWAHARLAL NEHRU TECHNOLOGICAL UNIVERSITY ANANTAPUR

This Memorandum of Understanding ("MoU") is made at Ananthapuramu on **01-07-2019** by and between **National Power Training Institute (NPTI)**, a National Apex body for Training and Human Resources Development in Power Sector, an autonomous organization of the Ministry of Power (MoP), Govt. of India having its Corporate Office at NPTI Complex, Sector-33, Faridabad-121 003, Haryana, (hereinafter referred to as 'NPTI', which expression shall unless repugnant to the subject or context be deemed to include its subsidiaries, associates and successors, in business and permitted assignees) of the first part

Jawaharlal Nehru Technological University Anantapur, established by AP Govt. Act No. 30 of 2008 dt: 18-08-2008 having its Administrative Office, Sri Thomas Manro Road at Ananthapuramu (hereinafter referred to as 'JNTUA', which expression shall unless repugnant to the subject or context be deemed to include its subsidiaries, associates and successors, in business and permitted assignees) of the second part.

(The above Organizations referred to as "Parties" in general throughout this agreement)

Whereas:

The parties have agreed that for mutual benefit of the organizations the following:

JNTUA

- JNTUA will facilitate conduct of short term seminars, workshops at its premises of constituent and or affiliated colleges by NPTI for the benefit of its students, faculty, etc. The infrastructure for such programs like auditorium / seminar hall / Lecture hall / hostel etc., will be provided by JNTUA. The excess revenue / expenditure in such programs shall be shared in the ratio of 40:60 by JNTUA and NPTI respectively.
- JNTUA shall allow the NPTI trainees / faculty to attend the short term programs conducted at its premises on equal footing basis, viz., number of man-days of training imparted by JNTUA is equal to number of man-days of training imparted by NPTI. The academic year will be considered as basis for such arrangement.
- JNTUA will recognize NPTI as an authorized Massive Open Online Course (MOOC) provider and facilitate its students / faculty to participate in on line Computer based Training programs run by NPTI as part of the curriculum requirement on chargeable basis by NPTI. The certificate issued by NPTI as part of this program shall be considered towards the internship and Massive Open Online Course (MOOC) requirement of the curriculum.
- JNTUA will allow its students / faculty to participate in the skill development programs conducted by NPTI on nominal fee and consider such programs towards the internship program as mandated by University curriculum.

NPTI

- NPTI will facilitate conduct of seminars, workshops, short term courses at its premises of constituent and or affiliated colleges by JNTUA for the benefit of its students, trainees, faculty, etc. The infrastructure for such programs like auditorium / seminar hall / Lecture hall / hostel etc will be provided by NPTI. The excess revenue / expenditure in such programs shall be shared in the ratio of 60:40 by NPTI and JNTUA respectively.

- NPTI will allow the students, faculties of JNTUA in the short term programs being organized by it on equal footing basis viz number of man-days of training imparted by NPTI is equal to number of man-days of training imparted by JNTUA. The academic year will be considered as basis for such arrangement.
- NPTI shall offer the online computer based training programs for the students, faculty of JNTUA in line with the MOOC requirements on chargeable basis. These shall be certificate programs as per the curriculum requirement of the university.
- NPTI will organize the skill development programs for the benefit of JNTUA students, faculty on chargeable basis and honor the commitments of the internship in the curriculum of the university.

Both JNTUA and NPTI:

- A Coordinator each shall be appointed from JNTUA and NPTI who will look after the duties of the conduct of the programs and correspondence in connection with this MoU.

The above coordinators will act as SPOC (Single- Point of Contact) for JNTUA and NPTI respectively.

The 'Parties' have to appoint another coordinator in case the above officers are not available. From NPTI, at any point of time the Training-in-charge concerned will be the SPOC. From JNTUA, at any point of time the Head, EEE Dept. of JNTUA CEA will be the SPOC.

Now therefore, in recognition of the facts stated above, NPTI and JNTUA witness that, in consideration of the mutual discussion held from time to time in the recent past, the parties, by virtue of this document, hereby agree to abide by the following framework:-

Terms:

This MoU shall be effective from the date of execution and shall continue for a period of five (5) years from such date and may be further extended based on mutual consent.

- **Cost:**
NPTI and JNTUA will bear their own expenses and costs that are incurred in connection with all activities relating to this MoU.
- **Amendment:**
This MoU may be amended or modified only with the mutual written consent of both the Parties.
- **Assignment:**
Neither this MoU nor any right granted hereunder shall be assignable or otherwise transferable by either Party.
- **Non-Binding Effect:**
This MoU shall not create any legal binding obligations upon either Party.
- **Termination:**
This MoU can be terminated by either party by a written notice of three (3) months.
- **Governing Law:**
This MoU will be governed by and construed in accordance with the laws of India ("Law"). This MoU shall be subject to the jurisdiction of Bangalore High Courts.
- **Others:**
This MoU is executed in 2 (two) original copies in English, both have the same legal power and meaning.
- **Communication:**
Any notice or other communication required or permitted to be given by or pursuant to this Memorandum of Understanding shall be sufficiently given if in writing and delivered personally or sent by prepaid registered post or facsimile.
