LICENSE AGREEMENT

THIS AGREEMENT is entered into on this **Fourth day of August, 2016** ("Effective Date") among (i) **INDIAN INSTITUTE OF TECHNOLOGY**, Madras (IITM), with offices at Sardar Patel Road, Chennai - 600036 ("LICENSOR"), **Blueprint IT**, a unit of SPE Trust, having their registered address at No. 8, Karpagambal Nagar, Mylapore, Chennai-4 (Authorized Support Partner)

(ii) Electronics & ICT Academy, National Institute of Technology, Warangal (EICT-NITW) ("Trainer")

And

(iii) JNT University Anantapur, Ananthapruamu. ("LICENSEE")

WHEREAS, LICENSEE wishes to obtain license from LICENSOR for the Database Licensed Program and to receive learning assistance from TRAINER, for the purpose of learning and IITM (LICENSOR) desires to grant license of these software, to LICENSEE. TRAINER desires to provide learning assistance related to software. Database Program License are exclusive and limited for the purpose of learning and to do the assignment for the NPTEL video lectures on Database Design course.

NOW THEREFORE, the LICENSEE agrees to the following terms and conditions, of the LICENSE from IITM and shall sign the License Agreement, in acceptance of the terms and conditions of the License, from IITM as set out hereunder.

### 1. GRANT OF LICENSE.

Subject to the terms and conditions of the Agreement, IITM grants to the LICENSEE, a non-exclusive, non-transferable LICENSE, to use the *Database Application software* (the "Licensed Programs") for the purpose of learning to do the assignment on Database Design course. LICENSEE may use the Licensed Programs in executable format, for this use of doing the assignments by the students. LICENSEE may not, however, transfer or sublicense the Licensed Programs to any third party in whole or in part in any form, whether modified or unmodified.

### 2. TRAINING ASSISTANCE

Subject to the terms and conditions of the Agreement, EICT-NITW as TRAINER provides learning assistance to the LICENSEE, a non-exclusive, non-transferable, assistance in learning the topics delivered by LICENSEE through the *Database Application software* (the "Licensed Programs") and do the assignment on Database Design course. LICENSEE may not, however, transfer or sublicense the learning modules, if any given by TRAINER, to any third party in whole or in part in any form, whether modified or unmodified. TRAINER can provide onsite assistance for a maximum of two times in a semester on demand.

#### 3. CONSIDERATION

- a. Licensee should have paid the license fees TO LICENSOR.
- b. Licensee should have paid the training fees to TRAINER.
- c. License fee of **Rs. 1,00,000/-** for each year of total 3 years time span from the effective date, do not include any shipping, duties, bank fees, sales use, excise, service tax or similar taxes due. If Licensor is required to pay any such amounts, Licensee shall reimburse Licensor, in full payable to IITM.
- d. Training fee of Rs. 20,000/- for each year of total 3 years time span from the effective date.

### 4. COPIES

Licensee may make copies of the Licensed Program in executable code form as necessary for use by Licensee and for backup or archive purposes. Licensee agrees to maintain records of the location and use of each copy, in whole or in part, of the Licensed Programs. Each Licensed Program is copyright but unpublished by IITM. Licensee agrees to reproduce and apply the copyright notice and proprietary notice of IITM to all copies made hereunder, in whole or in part and in any form, of Licensed Programs.

# 5. OWNERSHIP

The original and any copies of the Licensed Programs, made by LICENSEE, Including translations, compilations, partial copies, modifications, and update, are exclusively the property of IITM and the video will specify ownership of IIT Madras.

### 6. PROPRIETARY RIGHTS

LICENSEE recognizes that IITM regards the Licensed Programs as its proprietary information's and as confidential trade secrets of great value. Licensee agrees not to provide or to otherwise make available in any form the Licensed Programs, or any portion thereof, to any person other than employees of Licensee, without the prior written consent of IITM. Licensee further agrees to treat the Licensed Programs with at least the same degree of care and discretion with which Licensee treats its own confidential information

and in no event with less care than is reasonably required to protect the confidentiality of the Licensed Programs.

#### 7. TERM

a) The license granted hereby is initially valid for a period of one year, from the date of signing this Agreement and it shall continue to extend validity for a year upon payment of Rs 1,00,000/- and such extensions of validity can be made twice based on this agreement. The granted license is valid during the period of validity, unless and until terminated pursuant to Section 8 hereof and subject to Licensee's proper performance of its obligations hereunder.

b) The provision of learning assistance is initially valid for a period of one year, from the date of signing this Agreement and it shall continue to extend validity for a year upon payment of Rs 20,000/- and such extensions of validity can be made twice based on this agreement. The learning assistance is valid during the period of validity, unless and until terminated pursuant to Section 8 hereof and subject to Licensee's proper performance of its obligations hereunder.

#### 8. TERMINATION

IITM may terminate this Agreement if Licensee is in default of any of the terms and conditions of this Agreement and fails to correct such default within ten (10) days after written notice thereof from IITM. Upon termination or expiry of the License, all materials, data, information, videos, software, hardware or device provided by the Licensor shall be duly returned by the Licensee to the Licensor.

#### 9. TERMINATION CERTIFICATE

In the event of termination, Licensee will immediately discontinue use of the Licensed Programs Within one (1) month after the termination of this Agreement, Licensee will furnish to IITM a certificate, which certifies with respect to each of the Licensed Programs that, through its best effort and to the best of its knowledge, the original and all copies, in whole or in part and in any form, of each of the Licensed Programs have been destroyed. The provisions of Sections 4, 5, 8,11, and 13 here of shall survive any termination of this Agreement.

# 10. MAINTENANCE SUPPORT

The licensor will not provide any maintenance support. All documentation and front ending support will be provided by our partner Blueprint IT, having their registered address at 8, Karpagambal Nagar, Mylapore, Chennai 60 004. The Licensee shall not make payments towards maintenance charges, to Blueprint IT.

### 11. WARRANTY DISCLAIMER

IITM licenses, and LICENSEE accepts, the licensed programs "AS IS." The LICENSOR PROVIDES NO WARRANTIES AS TO THE FUNCTION OR USE OF THE LICENSED PROGRAMS, WHETHER EXPRESS, IMPLIED, OR STATUTORY, INCLUDING, WITHOUT LIMITATION, ANY IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR PARTICULAR PURPOSE. THE ENTIRE RISK AS TO THE PRODUCT, MATERIAL, INFORMATION, QUALITY AND PERFORMANCE, OF THE LICENSED PROGRAM IS WITH LICENSEE AND IITM SHALL IN NO EVENT BE LIABLE FOR ANY LOSS, DAMAGE, COST OR CONSEQUENCE RELATING TO THE USE OF THE LICENSE.

#### 15. SUCCESSORS

This Agreement will be binding upon and will inure the benefit of IITM and Licensee here to and their respective representatives, successors in interest and permitted assignees except as otherwise provided herein.

#### 16. SEVERABILITY

In the event any provision of this Agreement is determined to be invalid or unenforceable, the remainder of this Agreement shall remain in force as if such provision were not a part.

### 17. GOVERNING LAW/FORM

JNTUA will also pay EICT-NITW a training fee of Rs.20,000/- (Exclusive of Service Tax as applicable) for each year of total 3 years time span from the effective date for receiving learning assistance for the Database Application software.

The University shall need to pay a fee of Rs.2000/- (Exclusive of Service Tax as applicable) per student to IITM, who opt for a certification from IIT, Madras.
