- 4. Submission of I, II, III, IV & V Yrs online receipts/challan for verification at Head Quarters on <u>03.07.2021</u> (<u>Saturday</u>).
- 5. To submit the following at the time of verification along with online receipts/challan without which verification process will not undertaken
 - (a) Detained List signed by the college principal.
 - (b) Condoned List signed by the college principal along with online receipts/challan towards condonation fee.
 - (c) College Academic Committee (CAC) resolution approving detained and condonation Lists.
 - (d) 'Eligible but not registered' list signed by the college principal.
 - (e) Copy of Clearance Certificate.
 - (f) Copy of UCS Fee Receipts.
