Mandatory Eligibility Norms for the Institutions to apply for Permanent Affiliation:

- 1. The institution shall be in existence for at least **TEN** years.
- 2. The institution shall not have any deficiencies pointed out by the last university affiliation committee.
- 3. The institution shall not have any pending dues to the university as on the date of submission of application for permanent affiliation.
- 4. The institution shall pay salaries regularly through bank to both teaching and non teaching staff as per existing UGC/AICTE/PCI/State Govt. norms.
- 5. The institution shall maintain Student Teacher Ratio as per AICTE/PCI norms.
- 6. The institution shall have a minimum of 60% faculty retention for the last **FIVE** years.
- 7. The institution shall have a Principal qualified and eligible as per the norms of AICTE/PCI.

1.4 Faculty Members with Ph.D. Qualification:(10 marks)

For every faculty member with Ph.D. qualification 2 marks subject to the maximum of 10 marks.

<u>Note:</u> In case of non-availability of qualified Professor an Associate Professor maybe considered.

1.5 Faculty Research Activities in the last 3 years: (40 marks)

1.5.1 Publications last 3 years: (20 marks)

For every 20 publications in SCI/SCIE/SCOPUS/UGC-CARE/PEER REVIWED journals 4 marks subject to the maximum of 20 marks.

1.5.2 Patents last 3 years: (10 marks)

For every one Patent published/granted 2 marks subject to the maximum of 10 marks.

1.5.3 Research Projects last 3 years: (10 marks)

For every completed/ongoing Research Project with a project cost of Rs.10 Lakhs and above 2 marks subject to the maximum of 10 marks.

Mandatory Condition: The college shall score a minimum of 50% in criteria-1 to get eligibility to evaluate criteria-2 to criteria-5.

Note: (i) Multimedia computers (Minimum 10% of total Students) with internet surfing located in the reading room to access the online courses from the platforms like NPTEL, SWAYAM & SWAYAM PRABHA etc. shall be made available in the Digital Library.

(ii) Reprographic facility and document scanning facility are essential in the Library.

(iii) Library Automation software including bar coding is desirable.

4.2 Laboratory Facility: (50 Marks)

Note: The Laboratories shall have Equipment and software as appropriate for experiments as stated suitable for the requirements of affiliating University Curriculum. It is desired that the number of experimental set-up be so arranged that maximum three students (i.e.1:3) shall work on one set-up for hardware laboratories and 1:1 for software laboratories.
