INSTRUCTIONS TO CANDIDATES

Please read the instructions below before applying for admission into Ph.D. Full Time Programme

- 1) Applications for admission into full time Ph.D programme are invited in the following branches i.e.,
 - i) Chemical Engineering
 - ii) Civil Engineering
 - iii) Computer Science and Engineering
 - iv) Electrical and Electronics Engineering
 - v) Electronics and Communication Engineering
 - vi) Mechanical Engineering
- 2) University will admit those students who qualify for fellowship/scholarship in UGC-NET/UGC-CSIR NET/ GATE/CEED and similar National level tests based on an interview.
- 3) For reservation, Govt. of India (GOI) norms shall be followed
- 4) General/OBC Category candidates have to pay **Rs.1500/-** and SC/ST/PH Category candidates have to pay **Rs.1250/-** towards Application Registration fee in the form of Demand Draft in favor of “**The Registrar, JNT University Anantapur**”, payable at **SBI, JNTUEC Branch (Code No. 2723), Ananthapuramu.**
Note: Application Registration fee is non-refundable under any circumstances.
- 5) The filled application along with Demand Draft and photo copies of certificates must be sent to **the Director of Admissions, JNT University Anantapur, Ananthapuramu through Speed Post/Courier to reach on or before 12.06.2023, 5.00 PM.**
- 6) The List of photo copies of certificates to be enclosed with the application:

 - ii. Marks Memos/ Consolidate Marks Memo of M.Tech./M.E
 - iii. B.Tech./B.E. certificate
 - iv. Marks Memos/ Consolidated Marks Memo of B.Tech./B.E
 - v. Transfer Certificate
 - vi. Migration Certificate in case of other than JNTUA
 - vii. Integrated Caste Certificate
 - viii. Study Certificates of both UG and PG
 - ix. Valid UGC-NET/UGC-CSIR/GATE/CEED and similar national level test score card
 - x. SSC certificate
- 7) Application received after last date notified will not be entertained and no further correspondence will be made in this regard.
- 8) University will not be responsible for any delay at any stage. No correspondence / queries will be entertained regarding delays, conduct and reasons for not being called.
- 9) The University reserves the right not to admit any candidate in any discipline if none is found suitable / eligible.

- 10) The University reserves the right to alter / insert any corrections / additions in the advertisement / website etc. in the event of thing is observed.
- 11) The decision of the University in all matters will be final and binding. No correspondence / interim enquiry will be entertained from the candidates in connection with the process of selection.

- (iv) Application submitted in any other format will be summarily rejected and no correspondence, in this regard, will be entertained. Hence, the candidates are advised in their own interest to apply early enough to ensure timely submission of their applications on or before the closing date & time.
- (v) The applicant must ensure their eligibility for Ph.D. Admission-2023 in respect of qualifications and other requisite criteria and then only apply.
