POLICY STATEMENT:

Rapid growth and development of technology, has brought in many positive changes in the world and at the same time the sustainability and the environmental protection have come to forefront as leading concerns. JNTUA recognises the importance of the sustainable practices and will make all efforts to evolve into a green campus and contribute to the environmental protection in its own way.

STRATEGIES:

1. Spreading the awareness about the sustainability among the staff, faculty and students.
2. To implement measures like tree plantation, water conservation and automobile free campus .
3. Effective waste management like Installation of Biogas plant, recycling of garbage and promoting use of biodegradable materials instead of plastics.
4. Conducting Green Audit of the campus from time to time
5. Making Environmental Science as part of curriculum so that the social responsibility is recognised by the students.

IMPLEMENTATION:

1. **Tree Plantation:** The institution is keenly interested in converting the campus into a green campus through trees plantation programs periodically. Already in the last 5 years, tree plantation program has been taken up on important days by NSS and other departments. Massive tree plantation drive was undertaken throughout the campus and as a part of that several mango saplings , sapota saplings, guava saplings have been planted. Now they are

grown up and yielding fruits. The campus has also undergone a tremendous change. The lush greenery with scenic beauty has transformed the campus from a deserted look into a clean and green environment.

2. **Solid Waste Management:** A Biogas Plant is installed near the Girls Hostel in the campus. The plant uses the waste generated from the dining hall of the hostel and the Biogas produced by the plant is being used for cooking purposes. Thus, effective recycling of waste is being implemented which has resulted in cost reduction also.
3. **Rain Water Harvesting:** In order to improve the ground water levels and also a measure of water conservation, Rain Harvesting pits are dug not only in the main campus of the University, but also in the campuses of campuses of constituent units. In JNTUA CE, Kalikiri campus, the recycling of water is being implemented and is giving good results.
4. **Environment Audit:** University has undertaken Environmental auditing by third party and awarded Environment Audit certificate for 2019-20, 2020-21 and 2021-22. Further University also got ISO 14001:2015 from 01.03.2021 to 09.08.2024.
5. Environmental Science is already included in the curriculum as a mandatory course.
