SUB: APPGCET-2023- Admissions into M.A, M.Com, M.Ed and M.Sc., Courses in Universities and their Constituent Colleges and Govt. Colleges in A.P – Communication of guidelines to fill the leftover vacancies during Spot Admissions – Reg.

1. The **Principals of Universities and their Constituent Colleges & Govt. Colleges** in AP state are informed that the First Phase and Second & Final Phase of APPGCET-2023 Convener admissions are completed.

2. Principals are requested to comply for conducting spot admissions with the following sequence of operations:

- I. The Universities and their Constituent Colleges & Govt. Colleges have to complete Not admit/Admit process before taking up Spot Admissions as per the following procedure.
  - The vacant seat shall be filled with the same category candidate on merit of APPGCET-2023 rank.
  - If same category candidate is not available, seat shall be filled with the candidate as per seat conversion matrix given in Table-1.
- II. Update the joining details by logging into <https://cets.apsche.ap.gov.in> with the UserID already being used for updating joining details.
- III. Derive Spot Vacancy. The unfilled and not joined / dropout vacant seats will now become vacancies for Spot admissions.

3. Please comply the following scrupulously:

- I. Issue a Notification in a Daily News paper indicating the date of Spot Admissions.
- II. Candidates who have not taken admission so far are only eligible. Candidates shall not be allowed for spot admission without original certificates.

III. The Vacancies under Spot admissions shall be filled with the candidates qualified in APPGCET-2023 and satisfying the prescribed educational qualifications given in APPGCET-2023 Notification.

IV. Candidates who satisfy the definition of Local/Non-Local shall alone be granted admission. Candidates whose qualifying examination is from other state but either of the parents resided for a period of 10 years in A.P/Telangana state are eligible for Spot Admissions.

V. Certificates to be Verified:

- Qualifying Examination Consolidated Marks Memo and Provisional Pass Certificate
- Eligibility for admission into a Course shall be as prescribed Educational qualifications given in APPGCET-2023 Notification
- Study Certificate
- APPGCET-2023 Rank card
- Residence Certificate (if applicable)
- Caste Certificate (if applicable)
- EWS Certificate (if applicable)
- Transfer Certificate

VI. Upload the original marks memos of all above certificates for verification and for ratification of spot admissions made by the colleges.

- VII. Principals are requested to collect the following processing fee from each candidate admitted through Spot admissions and remit to APSCHE through online payment gateway.
