(57) Abstract

It has been discovered that two silicon substrates can be simultaneously processed at the upper portion of the working table by using two spindles mounted in parallel on a headstock and a Y-axis driving section for controlling its movement back and forth along the front surface of the main body of the lathe; a headstock with two spindles mounted in parallel on its front surface; and a Z-axis driving section for controlling its movement.
