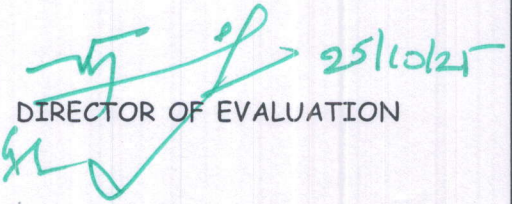

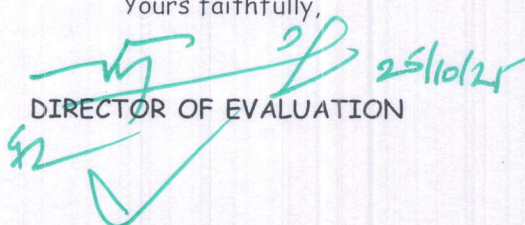
5. Students who are writing substitute subjects and additional subjects shall be registered manually with centre being the parent college only.

To submit the following at the time of verification along with Online receipts/Challans without which verification process will not undertaken

- (a) Detained List signed by the college principal.
- (b) Condoned List signed by the college principal along with Online receipts/Challan towards condonation fee.
- (c) College Academic Committee (CAC) resolution approving detained and condonation Lists.
- (d) 'Eligible but not registered' list signed by the college principal.
- (e) Copy of Clearance Certificate.
- (f) Copy of UCS Fee Receipts.

6. Deduction by the colleges is permissible as per the proceedings of the Registrar dated 07.04.2018 for Regular and 16.04.2014 for Supple, copies of which are available in www.jntua.ac.in under 'examinations'.
7. To note that hall tickets will be generated only for eligible students who have paid the UCS fee, for whom clearance has been given by the University and whose examinations fee has been received.
